CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A PIT WELL in the COZINE CREEK BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 64.1 ACRES.

The right has been perfected under Permit G-10202. The date of priority is JULY 26, 1983. The right is limited to not more than 0.80 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

S 1/2 SW 1/4, SECTION 18, T 4 S, R 4 W, W. M.; 670 FEET NORTH AND 1460 FEET EAST FROM THE SOUTHWEST CORNER OF SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, and shall be further limited to diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
