## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT G. MCKENZIE, JR. AND BEVERLY MCKENZIE BOX 187 PORT ORFORD, OREGON 97465

confirms the right to use the waters of AN UNNAMED STREAM, CEDAR CREEK, AND ELK RIVER, tributaries of the PACIFIC OCEAN, for IRRIGATING 164.8 ACRES.

This right was perfected under Permit 33963. The date of priority is NOVEMBER 6, 1968. This right is limited to 2.06 CUBIC FEET PER SECOND, BEING 0.45 CFS EACH FROM THE STREAM AND CEDAR CREEK AND 1.16 CFS FROM ELK RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NE 1/4, NE 1/4 NE 1/4, BOTH AS PROJECTED WITHIN DLC 39, SECTION 19, NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 39, SW 1/4 NW 1/4 SECTION 20, T 32 S, R 15 W, W.M.; STREAM - 740 FEET SOUTH AND 1850 FEET WEST, CEDAR CREEK - 890 FEET SOUTH AND 50 FEET WEST, 580 FEET SOUTH AND 480 FEET EAST, ELK RIVER - 2350 FEET SOUTH AND 950 FEET EAST; ALL FROM THE NW CORNER OF SECTION 20.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right is subject to the terms and conditions of an agreement between the Department of Fish and Wildlife and the applicant, a copy of which has been recorded in the Miscellaneous Records of the Water Resources Department and by reference made a part hereof.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
