CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCHARF FARMS 9950 BETHEL ROAD AMITY, OREGON 97101

confirms the right to use the waters of SCHARF RESERVOIR CONSTRUCTED UNDER PERMIT R-5319, a tributary of SALT CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 203.7 ACRES.

This right has been perfected under Permit 45905. The date of priority is AUGUST 15, 1980. This right is limited to 29.5 ACRE-FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 4 (SW 1/4 SW 1/4), SECTION 15, T 6 S, R 5 W,W.M.; 680 FEET NORTH AND 1590 FEET WEST FROM THE S 1/4 CORNER OF SECTION 15.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet for each acre irrigated during the irrigation season of each year from storage. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
