CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SCHARF FARMS

confirms the right to use the waters of ASH SWALE and RESERVOIRS constructed under Permits R-2038 and R-8399, tributaries of SALT CREEK, for the purpose of IRRIGATING 169.5 ACRES.

The right has been perfected under Permit 48546. The date of priority is MAY 22, 1984. The right is limited to not more than 1.21 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 19, T 6 S, R 4 W, W. M.; 1000 FEET SOUTH AND 800 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre FROM DIRECT FLOW, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
