CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of MCNABB CREEK AND MCNABB CREEK RESERVOIR, CONSTRUCTED UNDER PERMIT R-10449, a tributary of OLALLA CREEK, for the purpose of MAINTENANCE OF RESERVOIR FOR FIRE CONTROL, WATERING ROADS, AND MIXING PESTICIDE.

This right has been perfected under Permit 49258. The date of priority is OCTOBER 31, 1984. This right is limited to 1.0 CUBIC FEET PER SECOND, BEING 0.01 CFS FROM MCNABB CREEK TO MAINTAIN MCNABB CREEK RESERVOIR FOR FIRE CONTROL; 1.0 CFS FOR FIRE CONTROL; 0.7 CFS, BUT NOT TO EXCEED 98,000 GALLONS PER YEAR FOR ROAD WATERING AND 0.7 CFS, BUT NOT TO EXCEED 3,250 GALLONS PER YEAR FOR MIXING PESTICIDES, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 11, T 29 S, R 7 W, W.M.; 330 FEET SOUTH AND 110 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 11.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

The right allowed here shall not authorize appropriation of direct flow water from McNabb Creek during the period from the first day of June through the 30th day of September of each year. Water legally stored may be used at any time.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
