CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of NORTH YAMHILL RIVER, a tributary of YAMHILL RIVER, for the purpose of IRRIGATING 35.0 ACRES.

This right has been perfected under Permit 49476. The date of priority is SEPTEMBER 4, 1985. This right is limited to 0.44 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 31, T 2 S, R 4 W, W.M.; 300 FEET NORTH AND 1450 FEET ~~SOUTH~~ EAST FROM THE SW CORNER OF SECTION 31.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
