CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DARRELL L. BIGELOW

confirms the right to use the waters of LONG BRANCH CREEK, a tributary of PINE CREEK, for the purpose of PRIMARY IRRIGATION OF 3.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 74.5 ACRES.

The right has been perfected under Permit 49591. The date of priority is OCTOBER 2, 1985. The right is limited to not more than 1.96 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 6, T 8 S, R 47 E, W.M.; 2500 FEET NORTH AND 2120 FEET EAST FROM THE SW CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
