CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DAVID WHITE
ROUTE 2, BOX 241
VALE, OREGON 97918

confirms the right to use the waters of A SERIES OF SPRINGS, a tributary of WILLOW CREEK, for the purpose of PRIMARY IRRIGATION OF 25.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 3.7 ACRES.

This right has been perfected under Permit 46251. The date of priority is JULY 8, 1981. This right is limited to 0.73 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

DIVERSION 1 - SW 1/4 NW 1/4, 2770 FEET NORTH AND 70 FEET EAST;
2 - NW 1/4 SW 1/4, 1520 FEET NORTH AND 1250 FEET EAST; 3 - SE 1/4 SW 1/4, 30 FEET NORTH AND 2640 FEET EAST, ALL FROM THE SW CORNER OF SECTION 23, T 17 S, R 44 E, W.M.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

TOWNSHIP 17 SOUTH, RANGE 44 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
