CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALVIN AND MAGGIE BROWN
ROUTE 1, BOX 938
DAYVILLE, OREGON 97825

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of the PRIMARY IRRIGATION OF 14.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 63.2 ACRES.

The right has been perfected under Permit 46353. The date of priority is AUGUST 5, 1981. The right is limited to not more than 1.39 CUBIC FEET PER SECOND, BEING 0.36 CFS FOR PRIMARY IRRIGATION AND 1.03 CFS FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 27, T 12 S, R 26 E, W.M.; 170 FEET NORTH AND 1000 FEET WEST FROM THE SE CORNER OF SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
