CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of ROGUE RIVER, a tributary of PACIFIC OCEAN, for the purpose of IRRIGATING 35.5 ACRES.

This right has been perfected under Permit 49758. The date of priority is JULY 10, 1986. This right is limited to 0.44 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - NW 1/4 SW 1/4 SECTION 25; 2 - SE 1/4 SW 1/4 SECTION 26;
3 - SW 1/4 SW 1/4 SECTION 26, ALL IN T 36 S, R 4 W, W.M.; 1 - 1850 FEET NORTH AND 575 FEET EAST FROM THE SW CORNER OF SECTION 25; 2 - 1670 FEET SOUTH AND 1720 FEET EAST FROM THE EAST 1/4 OF SECTION 27; 3 - 1350 FEET SOUTH AND 260 FEET EAST FROM THE EAST 1/4 OF SECTION 27.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NW 1/4 SW 1/4 SECTION 25	3.4 ACRES
NE 1/4 SW 1/4	5.1 ACRES
NW 1/4 SW 1/4	4.0 ACRES
SE 1/4 SW 1/4	2.8 ACRES
NE 1/4 SE 1/4	10.1 ACRES
NW 1/4 SE 1/4	3.5 ACRES
SW 1/4 SE 1/4 SECTION 26	6.6 ACRES

TOWNSHIP 36 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
