CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E.D. AND INA L. BREIER
ROUTE 1, BOX 325
DRAIN, OREGON 97435

confirms the right to use the waters of SPRINGS 1, 2, 3 AND 4, tributaries of PASS CREEK, for the purpose of DOMESTIC USE FOR TWO FAMILIES INCLUDING THE IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN.

This right has been perfected under Permit 49879. The date of priority is SEPTEMBER 10, 1986. This right is limited to 0.01 CUBIC FOOT PER SECOND, BEING 0.003 CFS EACH FROM SPRINGS 1 AND 2 AND 0.002 CFS EACH FROM SPRINGS 3 AND 4, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - SW 1/4 SE 1/4, 2 - SW 1/4 SE 1/4, 3 - SE 1/4 SE 1/4, all in Section 26, 4 - NE 1/4 NE 1/4, Section 35, ALL WITHIN DLC 37, T 21 S R 5 W, W.M.; 1 - 710 FEET SOUTH AND 760 FEET EAST FROM THE NORTHWEST CORNER OF DLC 37, SECTION 26; SPRING 2 - 770 FEET SOUTH AND 740 FEET EAST FROM THE NORTHWEST CORNER OF DLC 37, SECTION 26; SPRING 3 - 1260 FEET SOUTH AND 1100 FEET EAST FROM THE NORTHWEST CORNER OF DLC 37, SECTION 26; SPRING 4 - 1660 FEET SOUTH AND 1000 FEET EAST FROM THE NORTHWEST CORNER OF DLC 37, SECTION 35; ALL WITHIN DLC 37, T 21 S, R 5 W, W.M.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NE 1/4 NE 1/4
AS PROJECTED WITHIN DLC 37
SECTION 35
TOWNSHIP 21 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
