confirms the right to use the waters of SCHMORE WELL in the SWAN LAKE BASIN for the purpose of IRRIGATING 274.3 ACRES.

The right has been perfected under Permit G-6835. The date of priority is SEPTEMBER 30, 1976. The right is limited to not more than 3.43 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NE 1/4, SECTION 7, T 38 S, R 11 1/2 E, W.M.; 3820 FEET NORTH AND 4250 FEET EAST FROM THE E 1/4 CORNER OF SECTION 12, T 38 S, R 10 E, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
