CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A WELL in the DEEP CREEK BASIN for the purpose of irrigation of 113.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 118.1 ACRES.

This right has been perfected under Permit G-8643. The date of priority is AUGUST 6, 1979. This right is limited to 1075 GALLONS PER MINUTE or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 NW 1/4, SECTION 4, T 2 S, R 4 E, W.M.; 2720 FEET SOUTH AND 2610 FEET EAST FROM THE SW CORNER OF SECTION 4.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
