CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHNNY EYGABROAD 7911 UPPER DEER CREEK ROAD SELMA, OREGON 97538

confirms the right to use the waters of A SUMP in the ILLINOIS RIVER BASIN for the purpose of IRRIGATION OF 76.9 ACRES AND SUPPLEMENTAL IRRIGATION OF 160.4 ACRES.

The right has been perfected under Permit G-9518. The date of priority is JANUARY 5, 1981. The right is limited to not more than 2.9 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The sump is located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 37, SECTION 14, T 38 S, R 7 W, W.M.; 1070 FEET SOUTH AND 970 FEET EAST FROM NW CORNER SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
