CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARLEN AND RICK WEAVER  
751 SW BILLIS ROAD  
MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of TWO WELLS in the SOUTH UMPQUA RIVER BASIN for the purpose of IRRIGATION OF 9.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 13.3 ACRES.

This right was perfected under Permit G-10207. The date of priority is AUGUST 5, 1983. This right is limited to not more than 0.29 CUBIC FOOT PER SECOND, BEING 0.17 CFS FROM WELL 1 AND 0.12 CFS FROM WELL 2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NE 1/4 SE 1/4, NE 1/4 SW 1/4, SECTION 32, T 29 S, R 5 W, W.M.;  
WELL 1 - 1600 FEET NORTH AND 1240 FEET WEST, WELL 2 - 2270 FEET NORTH AND 2690 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 32.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands shall be limited ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which this right is appurtenant, is as follows:
