CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARLEN AND RICK WEAVER  
751 SW BILLIS ROAD  
MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of SOUTH UMPQUA RIVER AND A UNNAMED STREAM, a tributary of UMPQUA RIVER, for the purpose of PRIMARY IRRIGATION OF 13.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 14.0 ACRES.

The right has been perfected under Permit 47771. The date of priority is AUGUST 5, 1983. The right is limited to not more than 0.27 CUBIC FOOT PER SECOND, BEING 0.18 CFS FROM SOUTH UMPQUA RIVER AND 0.09 CFS FROM UNNAMED STREAM or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SE 1/4 NW 1/4, SECTION 32, T 29 S, R 5 W, W.M.;  
S. UMPQUA - 1270 FEET NORTH AND 740 FEET WEST FROM THE SE CORNER OF SECTION 32, UNNAMED STREAM - 3850 FEET NORTH AND 2600 FEET EAST FROM THE SW CORNER OF SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year provided further that although declared herein to be for supplemental irrigation in part the right allowed may, in the interest of conserving the ground water supplies, be exercised at times when water is available in the ground water supply provided that the total quantity diverted from all sources of supply does not exceed the limitation allowed herein.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
