CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN D. PETSHOW
STAR ROUTE, BOX 210
FOREST GROVE, OREGON 97116

confirms the right to use the waters of A SPRING AREA, WHITE'S CREEK, GALES CREEK, AND AN UNNAMED RESERVOIR, tributaries of GALES CREEK, for the purpose of IRRIGATING 168.9 ACRES, FISH CULTURE, AND RECREATION.

This right has been perfected under Permit 43206. The date of priority is JUNE 28, 1972. This right is limited to not more than 1.07 CUBIC FEET PER SECOND BEING 0.09 CFS FROM THE SPRING AREA AND RESERVOIR FOR FISH CULTURE AND RECREATION, AND 0.98 CFS FROM WHITE'S CREEK AND RESERVOIR WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM EITHER SOURCE TO BE MADE UP BY DIVERSION FROM GALES CREEK.

The points of diversion are located as follows:

NE 1/4 SE 1/4, NW 1/4 SE 1/4, SE 1/4 SW 1/4, ALL AS PROJECTED WITHIN D. HARPER DLC 38, SECTION 36, T 2 N, R 5 W, W.M.; GALES CREEK - 2540 FEET NORTH AND 260 FEET WEST; SPRING AREA - 2650 FEET NORTH AND 900 FEET WEST; WHITE'S CREEK - 970 FEET NORTH AND 1800 FEET WEST; ALL FROM THE SE CORNER OF DLC 38.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
