CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WILLAMETTE RIVER AND STORAGE FROM WILLAMETTE BASIN PROJECT CONSTRUCTED UNDER PERMIT R-1625 AND R-5363, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATION OF 31.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.4 ACRES.

This right has been perfected under Permit 41836. The date of priority is MARCH 17, 1977. This right is limited to 0.56 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 29, SE 1/4 SE 1/4, SECTION 30, T 7 S, R 3 W, W.M.; 1 - 720 FEET EAST AND 660 FEET NORTH, 2 - 1100 FEET NORTH AND 1240 FEET WEST, ALL FROM THE SE CORNER OF SECTION 30.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from direct flow and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right is subject to the terms and conditions of Contract No. 7-07-10-W0012 or a satisfactory replacement between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
