CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELTON L. HALE 78763 RAT CREEK RD. COTTAGE GROVE, OREGON 97424

confirms the right to use the waters of A SPRING, RAT CREEK, AN UNNAMED STREAM AND HALE RESERVOIR, CONSTRUCTED UNDER PERMIT R-6653, tributaries of ROW RIVER, for DOMESTIC USE FOR ONE FAMILY FROM A SPRING, IRRIGATING 4.8 ACRES FROM RAT CREEK AND 0.6 ACRE FROM UNNAMED STREAM, STOCK USE FROM RAT CREEK, AND MAINTAINING OF A RESERVOIR UNDER PERMIT R-6653 FROM RAT CREEK AND AN UNNAMED STREAM FOR FISH CULTURE.

This right was perfected under Permit 41994. The date of priority is AUGUST 23, 1977. This right is limited to 0.098 CUBIC FOOT PER SECOND, BEING 0.005 CFS FROM THE SPRING FOR DOMESTIC USE; 0.075 CFS FROM RAT CREEK, BEING 0.005 CFS FOR STOCK USE, 0.06 CFS FOR IRRIGATION AND 0.01 CFS TO MAKE UP ANY DEFICIENCY FROM UNNAMED STREAM FOR FISH CULTURE; 0.018 CFS FROM UNNAMED STREAM AND RESERVOIR, BEING 0.008 CFS FOR IRRIGATION AND 0.01 CFS FOR FISH CULTURE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from direct flow and 2.5 acre-feet for each acre irrigated during the irrigation season of each year from direct flow and storage.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
