CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WILLAMETTE RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 64.3 ACRES.

This right has been perfected under Permit 43760. The date of priority is APRIL 3, 1978. This right is limited to 0.80 CUBIC FOOT PER SECOND, BEING 0.63 CFS FROM RIVER AND 0.17 CFS FROM SLOUGH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 66, SECTION 24, NE 1/4 NE 1/4, NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 66, SECTION 25, T 14 S, R 5 W, W.M.; SLOUGH - 2500 FEET SOUTH AND 4600 FEET WEST, RIVER - 4150 FEET SOUTH AND 3450 FEET WEST, 4350 FEET SOUTH AND 4130 FEET WEST, ALL FROM THE NE CORNER OF DLC 49.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
