## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRED B. SCHREECK ROUTE 1, BOX 29-B HAINES, OREGON 97833

confirms the right to use the waters of THREE UNNAMED SEEPAGE AREAS, a tributary of WILLOW CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 30.4 ACRES.

This right has been perfected under Permit 42339. The date of priority is JUNE 17, 1977. This right is limited to 0.76 CUBIC FOOT PER SECOND; BEING 0.44 CFS FROM POND 1, 0.14 CFS FROM POND 2, AND 0.18 CFS FROM POND 3 or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 NW 1/4, SE 1/4 NW 1/4, SECTION 2, SE 1/4 NE 1/4, SECTION 3, T 8 S, R 38 E, W.M.; POND 1 - 1240 FEET SOUTH AND 1240 FEET EAST; POND 2 - 1830 FEET SOUTH AND 1440 FEET EAST; POND 3 - 2120 FEET SOUTH AND 610 FEET WEST ALL FROM THE NW CORNER OF SECTION 2.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
