CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DOROTHY H. BOHANNAN 14685 HIGHWAY 238 JACKSONVILLE, OREGON 97530

confirms the right to use the waters of the APPLEGATE RIVER, a tributary of the ROGUE RIVER, for the PRIMARY IRRIGATION OF 8.1 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 3.7 ACRES.

This right was perfected under Permit 3743. The date of priority is MARCH 25, 1918. This right is limited to 0.147 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SW 1/4, AS PROJECTED WITHIN DLC 39, SECTION 30, T 38 S, R 3 W, W.M.; KUBLI DITCH - 2510 FEET SOUTH AND 3370 FEET WEST FROM THE NE CORNER OF DLC 39.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated from April 2 to October 31 of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 65145, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered JULY 19, 1991, approving Transfer Application 6515.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
