## CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the JOHN DAY RIVER, a tributary of the COLUMBIA RIVER, for the purpose of FROST PROTECTION FOR 123.6 ACRES.

This right has been perfected under Permit 41184. The date of priority is OCTOBER 20, 1976. This right is limited to 18.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SE 1/4 NE 1/4, NW 1/4 SE 1/4, SECTION 30, SE 1/4 SE 1/4 SECTION 19, T 9 S, R 26 E, W.M.; DIVERSION 1 - 620 FEET SOUTH AND 730 FEET WEST, DIVERSION 2 - 1800 FEET SOUTH AND 750 FEET WEST, DIVERSION 3 - 3510 FEET SOUTH AND 1330 FEET WEST ALL FROM THE NE CORNER OF SECTION 30; DIVERSION 4 - 200 FEET SOUTH AND 700 FEET EAST FROM THE NW CORNER OF THE SE 1/4 SE 1/4, SECTION 19.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
