## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALTER INGOLF AND CONSTANCE R. BERG 2901 MURPHY CREEK ROAD GRANTS PASS, OREGON 97527

confirms the right to use the waters of TWO WELLS in the MURPHY CREEK BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 7.5 ACRES.

The right has been perfected under Permit G-9694. The date of priority is SEPTEMBER 8, 1981. The right is limited to not more than 0.1 CUBIC FOOT PER SECOND, BEING 0.03 CFS FROM WELL 1 AND 0.07 CFS FROM WELL 2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - LOT 7 (NW 1/4 NE 1/4), SECTION 2, T 38 S, R 6 W, W.M.; 2060 FEET SOUTH AND 760 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 2; WELL 2 - LOT 10 (SW 1/4 NE 1/4), SECTION 2, T 38 S, R 6 W, W.M.; 2840 FEET SOUTH AND 550 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 2.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 7 (NW 1/4 NE 1/4) 3.0 ACRES
LOT 8 (NE 1/4 NE 1/4) 0.5 ACRE
LOT 10 (SW 1/4 NE 1/4) 4.0 ACRES
SECTION 2
TOWNSHIP 38 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
