## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J. FRANK SCHMIDT III P.O. BOX 189 BORING, OREGON 97009

confirms the right to use the waters of AN UNNAMED CREEK AND GOODWIN RESERVOIR, CONSTRUCTED UNDER PERMIT R-10821, a tributary of DOANE CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 112.7 ACRES AND CONTAINER STOCK ON 12.5 ACRES.

The right has been perfected under Permit 49928. The date of priority is SEPTEMBER 4, 1986. The right is limited to not more than 1.50 CUBIC FEET PER SECOND, BEING 1.41 CFS FOR SUPPLEMENTAL IRRIGATION AND 1.5 CFS FOR CONTAINER STOCK, PROVIDED THE TOTAL QUANTITY OF WATER DIVERTED AT ANY ONE TIME DOES NOT EXCEED 1.50 CFS or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 27, T 1 S, R 4 E, W.M.; 180 FEET NORTH AND 140 FEET EAST FROM SOUTHWEST CORNER SECTION 27.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
