CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EDWARD A. AND SANDRYA T. DANEHY  
240 SHIPLEY TERRACE  
PROSPECT, OREGON 97536

confirms the right to use the waters of A SPRING, EVERGREEN CREEK, RESERVOIR 1 AND RESERVOIR 2, CONSTRUCTED UNDER PERMIT R-8901, a tributary of EVERGREEN SPRING CREEK/ROGUE RIVER, for IRRIGATING 0.9 ACRE AND BEAUTIFICATION.

This right was perfected under Permit 47931. The date of priority is JULY 8, 1981 FOR IRRIGATION AND MAY 3, 1983 FOR BEAUTIFICATION. This right is limited to 0.041 CUBIC FOOT PER SECOND, BEING 0.011 CFS FROM EVERGREEN SPRING CREEK FOR IRRIGATION; 0.01 CFS FROM SPRING FOR MAINTAINING WATERFALL FOUNTAIN FOR BEAUTIFICATION; 0.01 CFS FROM EVERGREEN SPRING CREEK FOR MAINTAINING RESERVOIR 1 FOR BEAUTIFICATION; AND 0.01 CFS FROM EVERGREEN SPRING CREEK FOR MAINTAINING RESERVOIR 2 FOR BEAUTIFICATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NW 1/4, SECTION 17, T 33 S, R 2 E, W.M.; SPRING - 915 FEET NORTH AND 146 FEET WEST; RESERVOIR 1 - 725 FEET NORTH AND 76 FEET WEST; RESERVOIR 2 - 700 FEET NORTH AND 90 FEET WEST; ALL FROM THE CENTER 1/4 CORNER OF SECTION 17.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NW 1/4 0.9 ACRE  
SE 1/4 NW 1/4 WATERFALL/FOUNTAIN  
SE 1/4 NW 1/4 RESERVOIR MAINTENANCE

SECTION 17  
TOWNSHIP 33 SOUTH, RANGE 2 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
