CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH M. ROWLAND 24664 ERVIN ROAD PHILOMATH, OREGON 97370

confirms the right to use the waters of MARK J RESERVOIR CONSTRUCTED UNDER PERMIT R-8514, a tributary of BULL RUN CREEK, for the purpose of IRRIGATING 0.8 ACRE AND SUPPLEMENTAL IRRIGATION OF 1.1 ACRES.

The right has been perfected under Permit 47081. The date of priority is JUNE 15, 1982. The right is limited to not more than 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 61, SECTION 35, T 12 S, R 6 W, W.M.; 1080 FEET SOUTH AND 1240 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 35. RESERVOIR IS LOCATED 1050 FEET SOUTH AND 1150 FEET WEST FROM THE NORTH 1/4 CORNER OF SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre from direct flow, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NW 1/4 1.1 ACRES STORED WATER ONLY - SUPPLEMENTAL NE 1/4 NW 1/4 0.8 ACRE BULL RUN CREEK AND RESERVOIR - PRIMARY AS PROJECTED WITHIN DLC 61

SECTION 35
TOWNSHIP 12 SOUTH, RANGE 6 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
