CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACK E. DOWNS

JACKSONVILLE, OREGON 97530

confirms the right to use the waters of APPLIGATE RIVER AND APPLIGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 1.0 ACRE.

The right has been perfected under Permit 50108. The date of priority is MAY 8, 1987. The right is limited to not more than 0.025 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 37 SECTION 25, T 38 S, R 4 W, W.M.; 1550 FEET SOUTH AND 1890 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 25. DAM IS LOCATED S 1/2 SE 1/4, SECTION 25, T 40 S, R 4 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. This right is subject to the terms and conditions of Contract No. 7-07-10-W0682, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 NE 1/4 0.6 ACRE
SW 1/4 NE 1/4 0.4 ACRE
BOTH AS PROJECTED WITHIN DLC 37
SECTION 25
TOWNSHIP 38 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
