CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOSEPH E. AND PAMELA A. GOUVEIA 14921 NORTH APPLEGATE ROAD GRANTS PASS, OR 97527

confirms the right to use the waters of STORED WATER ONLY FROM APPLEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of APPLEGATE RIVER, for IRRIGATING 3.8 ACRES.

This right was perfected under Permit 50627. The date of priority is MARCH 8, 1988. This right is limited to 10.0 ACRE-FEET OF STORED WATER EACH YEAR MEASURED AT THE POINT OF DIVERSION ON AN UNNAMED SLOUGH.

The points of diversion are located as follows:

APPLEGATE LAKE RESERVOIR DAM: WITHIN S 1/2 SE 1/4, SECTION 25, T 38 S, R 4 W, W.M.; UNNAMED SLOUGH: NW 1/4 NE 1/4, SECTION 7, T 38 S, R 4 W, W.M.; 560 FEET SOUTH AND 462 EAST FROM THE NORTH 1/4 CORNER OF SECTION 7.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The water user shall comply with the terms and conditions of CONTRACT NO. 9-07-10-W0729 dated OCTOBER 24, 1988, between BUREAU OF RECLAMATION and MELVIN AND JODIE ESPEN AND ASSIGNED TO JOSEPH AND PAMELA GOUVEIA ON JANUARY 31, 1990. A copy of the CONTRACT is on file with the Water Resources Department.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NE 1/4 3.8 ACRES SECTION 7
TOWNSHIP 38 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
