CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HARRY L. AND JUNE D. OREM
20000 HIGHWAY 50
MERRILL, OREGON 97633

confirms the right to use the waters of SPRING CREEK, a tributary of WILLIAMSON RIVER, for DOMESTIC USE FOR ONE FAMILY INCLUDING THE IRRIGATION OF NOT TO EXCEED ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN.

This right was perfected under Permit 51172. The date of priority is DECEMBER 10, 1990. This right is limited to 0.01 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 4, T 34 S, R 7 E, W.M.; 450 FEET NORTH AND 345 FEET EAST FROM THE SE CORNER OF THE NE 1/4 SE 1/4 SET BY LS 2459, OR 450 FEET NORTH AND 300 FEET EAST FROM THE SE CORNER OF THE NE 1/4 SE 1/4 SET BY LS 4064 (THERE IS AN UNRESOLVED CONFLICT BETWEEN THE TWO CORNERS); NE 1/4 SE 1/4, SECTION 4, T 34 S, R 7 E, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE 1/4 SE 1/4
SECTION 4
TOWNSHIP 34 SOUTH, RANGE 7 EAST, W.M.

More explicitly described as Lots 19, 20, 21, and 22, Block 1, Idlerest Subdivision.

Failure to comply with any of the provisions of this right may result in action including, but not limited to restrictions on the use, civil penalties, or cancellation of the right.

This right is for the beneficial use of water without waste. The water user is advised that new regulations may require the use of best practical technologies or conservation practices to achieve this end.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
