confirms the right to use the waters of a WELL in the ZOLLNER CREEK BASIN for IRRIGATION OF 36.7 ACRES and SUPPLEMENTAL IRRIGATION OF 54.4 ACRES.

This right was perfected under Permit G-7296. The date of priority is MARCH 4, 1977. This right is limited to 0.45 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 NE 1/4, SECTION 11, T 6 S, R 1 W, W.M.; 820 FEET SOUTH AND 20 FEET EAST FROM THE NORTH 1/4 CORNER OF SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 1/2 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
