CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOUISE W. SLY ROUTE 1, BOX 35 HALFWAY, OREGON 97834

confirms the right to use the waters of PINE CREEK, a tributary of SNAKE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 79.5 ACRES. THE USE ALLOWED HEREIN MAY BE MADE ANYTIME BETWEEN OCTOBER 1 AND MARCH 31 THAT WATER CAN BE PUT TO BENEFICIAL USE BY IRRIGATION, EITHER FOR IMMEDIATE CROP GROWTH OF FOR FORECAST REQUIREMENTS TO RAISE THE SOIL MOISTURE TO FIELD CAPACITY IN THE SOIL PROFILE TO BE UTILIZED BY PLANT GROWTH IN THE SUBSEQUENT GROWING SEASON.

This right has been perfected under Permit 43532. The date of priority is JULY 27, 1977. This right is limited to 1.99 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 22, T 7 S, R 45 E, W.M.; 160 FEET SOUTH AND 200 FEET WEST FROM THE NE CORNER OF SECTION 22.

The amount of water used for irrigation shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1.5 acre-feet per acre for each acre irrigated during the period from October 1 to March 31, provided further that the right allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed 4.5 acre-feet for each acre irrigated in any one year. The use of water authorized herein shall not establish priority of right as against future appropriation of surface water for beneficial uses or for storage for such uses, other than similar rights for irrigation from October 1 to March 31. Sufficient flow shall be left in Pine Creek to provide domestic use and stockwater throughout its course during the period of use authorized herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:

NE 1/4 SW 1/4 14.0 ACRES NW 1/4 SW 1/4 28.8 ACRES SW 1/4 SW 1/4 36.7 ACRES

SECTION 36

TOWNSHIP 7 SOUTH, RANGE 45 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. This right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
