CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GRANT CORNELIUS
3375 S.W. 53RD
CORVALLIS, OREGON 97333

confirms the right to use the waters of MARYS RIVER, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 93.4 ACRES.

The right has been perfected under Permit 44195. The date of priority is MAY 4, 1979. The right is limited to not more than 1.17 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 55, T 12 S, R 5 W, W.M.; 850 FEET SOUTH AND 100 FEET WEST FROM THE NE CORNER OF DLC 55.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, (or its equivalent) for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
