CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CHARLES WARREN FARMER JR. AND JAMES GERALD FARMER PO BOX 1585 NYSSA, OREGON 97913

confirms the right to use the waters of AN UNNAMED WASTE DITCH AND LOCKET GULCH, a tributary of SNAKE RIVER, for SUPPLEMENTAL IRRIGATION OF 269.5 ACRES FROM UNNAMED WASTE DITCH AND 13.6 ACRES FROM LOCKET GULCH.

This right was perfected under Permit 49889. The date of priority is JUNE 4, 1986. This right is limited to 1594.4 GALLONS PER MINUTE, BEING 1500 GALLONS PER MINUTE FROM WASTE DITCH AND 94.4 GALLONS PER MINUTE FROM LOCKET GULCH or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

WASTE DITCH-SW 1/4 NE 1/4, SECTION 11, T 20 S, R 46 E, W.M.; 1490 FEET SOUTH AND 140 FEET EAST FROM THE N 1/4 CORNER SECTION 11.

LOCKET GULCH-SE 1/4 NW 1/4, SECTION 12, T 20 S, R 46 E, W.M.; 1880 FEET SOUTH AND 2550 FEET EAST FROM THE NW CORNER OF SECTION 12.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
