confirms the right to use the waters of WELL 2 in the WILD HORSE CREEK BASIN for IRRIGATION OF 156.9 ACRES and SUPPLEMENTAL IRRIGATION OF 115.6 ACRES.

This right was perfected under Permit G-3653. The date of priority is JULY 29, 1967. This right is limited to 3.20 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE¼ SW¼, SECTION 5, AND SW¼ NE¼, SECTION 8, T 38 S, R 11 E, W.M.; 1 - 270 FEET NORTH AND 2580 FEET EAST, 2 - 2610 SOUTH AND 3000 FEET EAST, BOTH FROM THE NW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
