CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WALTER N. AND MARGERY K. RITTER  
ROUTE 1 BOX 740  
BONANZA, OREGON 97623

confirms the right to use the waters of TWO WELLS in the WILD HORSE CREEK BASIN for IRRIGATION 2.0 ACRES.

This right was perfected under Permit G-6679. The date of priority is OCTOBER 29, 1975. This right is limited to 0.3 CUBIC FOOT PER SECOND, BEING 0.2 CFS FROM WELL 1 AND 0.1 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 5, AND SW $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 8, T 38 S, R 11 E, W.M.; 1 - 270 FEET NORTH AND 2580 FEET EAST, 2 - 2610 FEET SOUTH AND 3000 FEET EAST, BOTH FROM THE NW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 48370, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered October 14, 1991, approving Transfer Application 6483.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
