## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELVIN E. CARTER ROUTE 1, BOX 210 BAKER, OREGON 97814

confirms the right to use the waters of CARTER SUMPS 1 AND 2 in the PINE CREEK BASIN for the purpose of IRRIGATING 24.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 68.9 ACRES.

The right has been perfected under Permit G-6901. The date of priority is MAY 27, 1976. The right is limited to not more than 1.17 CUBIC FEET PER SECOND, BEING 1.02 CFS FROM SUMP 1 AND 0.15 CFS FROM SUMP 2 or its equivalent in case of rotation, measured at the sump.

The sumps are located as follows:

LOT 2 (SW 1/4 NW 1/4) AND SE 1/4 NW 1/4, SECTION 30, T 8 S, R 39 E, W.M.; SUMP 1 - 380 FEET NORTH AND 270 FEET EAST FROM THE W 1/4 CORNER OF SECTION 30. SUMP 2 - 820 FEET NORTH AND 60 FEET WEST FROM THE CENTER 1/4 CORNER OF SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
