CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BARRY HOUSE  
ROUTE 1, BOX 262B  
DAYTON, OREGON 97114

confirms the right to use the waters of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for the purpose of PRIMARY IRRIGATION OF 62.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 66.2 ACRES.

This right has been perfected under Permit 43209. The date of priority is FEBRUARY 18, 1977. This right is limited to 1.61 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 3 (NW 1/4 SW 1/4), SECTION 22, T 4 S, R 3 W, W.M.; 1440 FEET NORTH AND 450 FEET EAST FROM THE SE CORNER OF DLC 49.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
