CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING OF 32.8 ACRES.

This right has been perfected under Permit 47794. The date of priority is MAY 2, 1983. This right is limited to 0.82 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1 - SE 1/4 SW 1/4 OF SECTION 33, T 8 S, R 25 E, W.M.; 2 - NW 1/4 NW 1/4 OF SECTION 5, T 9 S, R 25 E, W.M. DIVERSION 1 - 900 FEET NORTH AND 3060 FEET EAST; DIVERSION 2 - 750 FEET SOUTH AND 300 FEET EAST; BOTH FROM THE NW CORNER OF SECTION 5, T 9 S, R 25 E, W.M.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.
