CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARK WICKERS AND DEAN DRAGES 21222 REDWOOD HIGHWAY KERBY, OR 97531

confirms the right to use the waters of MONTGOMERY CREEK, AN UNNAMED STREAM TRIBUTARY TO MONTGOMERY CREEK, AND TWO RESERVOIRS CONSTRUCTED UNDER PERMIT R-9396, a tributary of ILLINOIS RIVER, for IRRIGATION OF 1.6 ACRES AND SUPPLEMENTAL IRRIGATION OF 8.8 ACRES AND MAINTENANCE OF RESERVOIR FOR STOCK WATER.

This right was perfected under Permit 48270. The date of priority is FEBRUARY 9, 1984. This right is limited to 0.22 CUBIC FOOT PER SECOND, BEING 0.19 CFS FROM THE UNNAMED STREAM AND RESERVOIRS AND 0.02 CFS FROM MONTGOMERY CREEK FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION AND 0.01 CFS FROM THE UNNAMED STREAM AND RESERVOIRS FOR STOCK WATER or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

MONTGOMERY CREEK - NW 1/4 NW 1/4, SECTION 27, T 38 S, R 8 W, W.M.; 970 FEET SOUTH AND 1160 FEET EAST FROM THE NORTHWEST CORNER OF SECTION 27. UNNAMED STREAM - NE 1/4 NE 1/4, SECTION 28, T 38 S, R 8 W, W.M.; 1260 FEET SOUTH AND 810 FEET WEST FROM THE NORTHEAST CORNER OF SECTION 28.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FIFTIETH of one cubic foot per second (or its equivalent) and 3.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
