confirms the right to use the waters of THREE WELLS in the SANTIAM RIVER BASIN for IRRIGATION OF 29.0 ACRES.

This right was perfected under Permit G-5857. The date of priority is JUNE 18, 1973. This right is limited to 0.38 CUBIC FOOT PER SECOND, BEING 0.13 CFS FROM WELL 2, 0.14 CFS FROM WELL 3, AND 0.11 CFS FROM WELL 4, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 4, SW $\frac{1}{4}$ NE $\frac{1}{4}$, SECTION 9 AS PROJECTED WITHIN DLC 42, T 11 S, R 2 W, W.M.; WELL 2 - 810 FEET NORTH AND 570 FEET WEST, WELL 3 - 350 FEET NORTH AND 100 FEET WEST, WELL 4 - 1410 FEET SOUTH AND 50 FEET EAST, ALL FROM THE S $\frac{1}{4}$ CORNER OF SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
