CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

W. W. BEAM, ADMINISTRATOR ESTATE OF J. R. BEAM  
NYSSA, OREGON

confirms the right to use the waters of BEAM CREEK, a tributary of WILLOW CREEK, for IRRIGATION OF 155.8 ACRES, DOMESTIC AND STOCK USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for MALHEUR County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Page 258. The date of priority is 1880.

The use is limited to 3.895 SECOND FEET FROM APRIL 1ST TO MAY 1ST AND 1.947 SECOND FEET FROM MAY 1ST TO SEPTEMBER 1ST OF EACH YEAR, THE TOTAL QUANTITY DURING EACH IRRIGATION SEASON NOT TO EXCEED 227.4 ACRE FEET, CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, SECTION 27, T 14 S, R 38 E, W.M.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
