confirms the right to use the waters of A WELL in the DESCHUTES RIVER BASIN for the purpose of IRRIGATION OF 164.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 42.4 ACRES.

This right was perfected under Permit G-10662. The date of priority is JULY 21, 1986. The right is limited to 2.56 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 NW 1/4, SECTION 15, T 14 S, R 12 E, W.M. 900 FEET SOUTH AND 300 FEET EAST FROM THE NW CORNER OF SECTION 15.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
