CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A SUMP WELL WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE SUMP WELL TO BE MADE UP BY APPROPRIATION FROM WELL 1 WHEN AVAILABLE WITH ANY DEFICIENCY IN SUPPLY FROM WELL 1 TO BE MADE UP BY APPROPRIATION FROM WELL 2, ALL in the COQUILLE RIVER BASIN for TEMPERATURE CONTROL, FLOOD HARVESTING, AND IRRIGATION OF 24.0 ACRES.

This right was perfected under Permit G-10543. The date of priority is AUGUST 9, 1985. This right is limited to 3.6 CUBIC FOOT PER SECOND, BEING 3.6 CFS FOR TEMPERATURE CONTROL, 1.2 CFS FOR FLOOD HARVESTING, AND 0.6 CFS FOR IRRIGATION or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SW 1/4 SW 1/4 AND SE 1/4 SW 1/4, SECTION 4, T 28 S, R 14 W, W.M.; SUMP - 60 FEET NORTH AND 1600 FEET EAST; WELL 1 - 260 FEET NORTH AND 1400 FEET EAST; WELL 2 - 730 FEET NORTH AND 1180 FEET EAST; ALL FROM THE SOUTHWEST CORNER OF SECTION 4.

The amount of water diverted for CRANBERRY OPERATIONS, together with amounts secured under any other rights existing for the same lands, is limited as follows: For temperature control, 0.15 cubic foot per second per acre; For flood harvesting or pest control, 0.05 cubic foot per second per acre; For irrigation of cranberries, ONE-FORTIETH of one cubic foot per second and 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop, ONE-EIGHTIETH of one cubic foot per second and 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 SW 1/4 23.6 ACRES TEMP. CONTROL,

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
