CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALFRED A. ARNOLDUS AND HEIRS
ROUTE 1, BOX 16
SUMMERVILLE, OREGON 97876

confirms the right to use the waters of WILLOW CREEK, a tributary of GRANDE RONDE RIVER, for the purpose of IRRIGATING 5.5 ACRES AND SUPPLEMENTAL IRRIGATION OF 339.5 ACRES.

This right has been perfected under Permit 45003. The date of priority is MARCH 19, 1980. This right is limited to 2.95 CUBIC FEET CUBIC FOOT PER SECOND, BEING 0.05 CFS FOR PRIMARY IRRIGATION AND 2.90 CFS FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 23, T 1 S, R 38 E, W.M.; 10 FEET SOUTH AND 10 FEET WEST FROM THE NE CORNER OF SECTION 23.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
