## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LYNETTE GREGORY 3660 PLACER ROAD SUNNY VALLEY, OREGON 97497

confirms the right to use the waters of A SPRING AND GOOD TIME GULCH, a tributary of GRAVE CREEK, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 1.4 ACRES.

This right was perfected under Permit 46468. The date of priority is JANUARY 7, 1982. This right is limited to 0.023 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR SUPPLEMENTAL DOMESTIC USE AND 0.01 CFS FOR IRRIGATION FROM GOOD TIME GULCH AND 0.008 CFS FOR IRRIGATION FROM THE SPRING WITH ANY DEFICIENCY IN THE SUPPLY AT THE SPRING TO BE MADE UP BY DIVERSION OF WATER FROM THE GULCH or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 4, T 34 S, R 5 W, W.M.; SPRING - 60 FEET NORTH AND 90 FEET EAST, GULCH - 490 FEET NORTH AND 500 FEET EAST, BOTH FROM THE SOUTHWEST CORNER OF SECTION 4.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SPRING - SW/1/4 SW/1/4 0.6 ACRE

0.6 ACRE AND DOMESTIC

SUPPLEMENTAL

SW 1/4 SW 1/4 0.8 ACRE SECTION 4

TOWNSHIP 34 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
