CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

PHILIP MURPHY PO BOX 4 MONUMENT, OREGON 97864

confirms the right to use the waters of DRY CREEK, AN UNNAMED DRAW, NORTH FORK JOHN DAY RIVER AND USE OF 9.2 ACRE FEET OF STORED WATER FROM A RESERVOIR, CONSTRUCTED UNDER PERMIT R-10604, a tributary of JOHN DAY RIVER, for IRRIGATION OF 57.7 ACRES AND SUPPLEMENTAL IRRIGATION OF 102.9 ACRES.

This right was perfected under Permit 49608. The date of priority is JUNE 30, 1983 FOR 1.26 CFS FROM DRY CREEK FOR PRIMARY AND SUPPLEMENTAL IRRIGATION AND USE OF WATER FROM THE UNNAMED DRAW, NORTH FORK JOHN DAY RIVER AND RESERVOIR FOR SUPPLEMENTAL IRRIGATION; MARCH 27, 1986 FOR 1.28 CFS FROM NORTH FORK OF JOHN DAY RIVER FOR PRIMARY IRRIGATION. This right is limited to 2.54 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

1-SW 1/4 SW 1/4, SECTION 1, T 9 S, R 27 E, W.M.; 1100 FEET NORTH AND 900 FEET EAST FROM THE SW CORNER OF SECTION 1. 2-NE 1/4 NE 1/4, SECTION 11; 610 SOUTH AND 560 FEET WEST; 3-NE 1/4 SE 1/4, SECTION 11; 2650 FEET SOUTH AND 10 FEET WEST, 4-SE 1/4 NE 1/4, SECTION 11; 1700 FEET SOUTH AND 110 FEET WEST, 5-NE 1/4 NE 1/4, SECTION 11; 500 FEET SOUTH AND 180 FEET WEST, ALL FROM THE NE CORNER OF SECTION 11.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
