CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROBERT AND BETTY STOLZ
ROUTE 1 BOX 2030
BANDON, OREGON 97411

confirms the right to use the waters of CROOKED CREEK and RESERVOIR constructed under Permit R-1031, a tributary of PACIFIC OCEAN, for IRRIGATION OF 1.87 ACRES.

This right was perfected under Permit 19433. The date of priority is JUNE 6, 1949. This right is limited to 0.19 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 8, T 29 S, R 14 W, W.M..

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, if for irrigation of cranberries, shall be limited to ONE-TENTH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 0.75 acre foot for each acre irrigated in any thirty day period and shall be still further limited to a diversion of not to exceed 6 acre feet per acre during the irrigation season of each year. If for irrigation of any other crop, shall be limited to ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-1031.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This certificate describes that portion of the water right confirmed by Certificate 26566, State Record of Water Right Certificates, NOT cancelled under provisions of an order of the Water Resources Director entered November 25, 1991.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
