## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERA M. WHITE BOX 12, WEAVER ROAD MYRTLE CREEK, OR 97457

confirms the right to use the waters of ROCK CANYON CREEK (ALSO KNOWN AS CHADWICK CANYON), a tributary of SOUTH UMPQUA RIVER, for DOMESTIC USE FOR ONE FAMILY AND IRRIGATION OF 12.2 ACRES.

This right was perfected under Permit 34048. The date of priority is DECEMBER 17, 1968. This right is limited to 0.16 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC AND 0.155 CFS FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 40, SECTION 6, T 30 S, R 5 W, W.M.; DIVERSION 1 - 10 FEET SOUTH AND 30 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 6; NE 1/4 SE 1/4, SECTION 1, T 30 S, R 6 W, W.M.; DIVERSION 2 - 30 FEET SOUTH AND 120 FEET WEST, DIVERSION 3 - 20 FEET NORTH AND 130 FEET WEST, BOTH FROM THE EAST 1/4 CORNER OF SECTION 1.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NW 1/4 0.5 ACRE
NW 1/4 SW 1/4 11.7 ACRES, DOMESTIC ONE FAMILY
BOTH AS PROJECTED WITHIN DLC 40
SECTION 6
TOWNSHIP 30 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows
