## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

M.H. AND JULIA M. PINGLE P.O. BOX 7 BUTTE FALLS, OR 97522

confirms the right to use the waters of BUCK CREEK AND GEPPERT CREEK, a tributary of SOUTH FORK ROGUE RIVER, for IRRIGATION OF 85.0 ACRES AND DOMESTIC USE FOR THREE FAMILIES.

This right was perfected under Permit 41213. The date of priority is DECEMBER 3, 1976 FOR 0.09 CFS FROM BUCK AND GEPPERT CREEKS AND DECEMBER 27, 1976 FOR 0.98 CFS FROM GEPPERT CREEK. This right is limited to 1.07 CUBIC FEET PER SECOND, BEING 0.01 CFS FROM BUCK CREEK FOR DOMESTIC USE AND 1.06 CFS FROM GEPPERT CREEK FOR IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 SE 1/4 AND NE 1/4 SE 1/4, SECTION 26, T 33 S, R 3 E, W.M.; BUCK CREEK - 1660 FEET SOUTH AND 800 FEET WEST; GEPPERT CREEK - 1240 FEET SOUTH AND 320 FEET WEST, BOTH FROM THE EAST 1/4 CORNER OF SECTION 26.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 33 SOUTH, RANGE 3 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
